Award winners will be selected by the FCCFA Awards Committee and notified in June. Award winners will be invited to the FCCFA Annual Convention & Trade Show, where they will be presented with their award.

## **FCCFA Award Categories**

---

### **Funeral Director of the Year Award**

The Funeral Director of the Year Award is presented to an individual who has made outstanding contributions in the death care industry and has performed services over and above the norm. This award honors a professional who is employed as a licensed funeral director. The individual must be a current member of FCCFA and actively involved on a full-time basis in the death care industry.

### **Cemeterian of the Year Award**

The Cemeterian of the Year Award is presented to an individual who has accepted responsibilities and performed services over and above the norm. The award winner will have continually maintained high professional standards and have exhibited excellent qualities in the cemetery profession. The individual must be a current member of FCCFA and actively involved on a full-time basis in the death care industry.

### **Sales Representative of the Year Award**

The Sales Representative of the Year Award is presented to an individual who has shown their commitment to quality and drive to succeed. This individual has also developed successful salesmanship that has led to business plans that support growth and ensure profitability; and delivered strong results in an ethical manner.

### **Lifetime Achievement Award**

The Lifetime Achievement Award is presented to an individual to recognize and celebrate their contribution to the death care industry. This award is given in recognition of significant and sustained contributions to the death care industry for 30 or more years. The individual must be a current member of FCCFA and involved in the death care industry.

### **Supplier of the Year Award**

The Supplier of the Year Award is presented to an FCCFA supplier member who has made significant contributions and demonstrated leadership in the death care industry. These contributions may not necessarily be in service to FCCFA, although the nomination may be made for outstanding service to the Association. This award is to honor a supplier/vendor's overall business performance as regards providing the industry with world-class products and services as well as exceeding customer expectations.

### **Funeral Home, Cemetery, or Crematory Member of the Year Award**

The Funeral Home/ Cemetery/Crematory Member of the Year Award is presented to one FCCFA member establishment which has made significant contributions and demonstrated leadership in the death care industry. These contributions may not necessarily be in service to FCCFA, although the nomination may be made for outstanding service to the Association.
